All columns should be filled up and no column to be left blank. If there is no information to Note: 3. furnish in respect of any item, either "Nil" or "Not applicable", as the case may be, should

The affidavit should be either typed or written legibly and neatly. Note: 4.

Each page of the Affidavit should be signed by the deponent and the Affidavit should bear Note: 5. on each page the stamp of the Notary or Oath Commissioner or Magistrate before whom the Affidavit is sworn.
