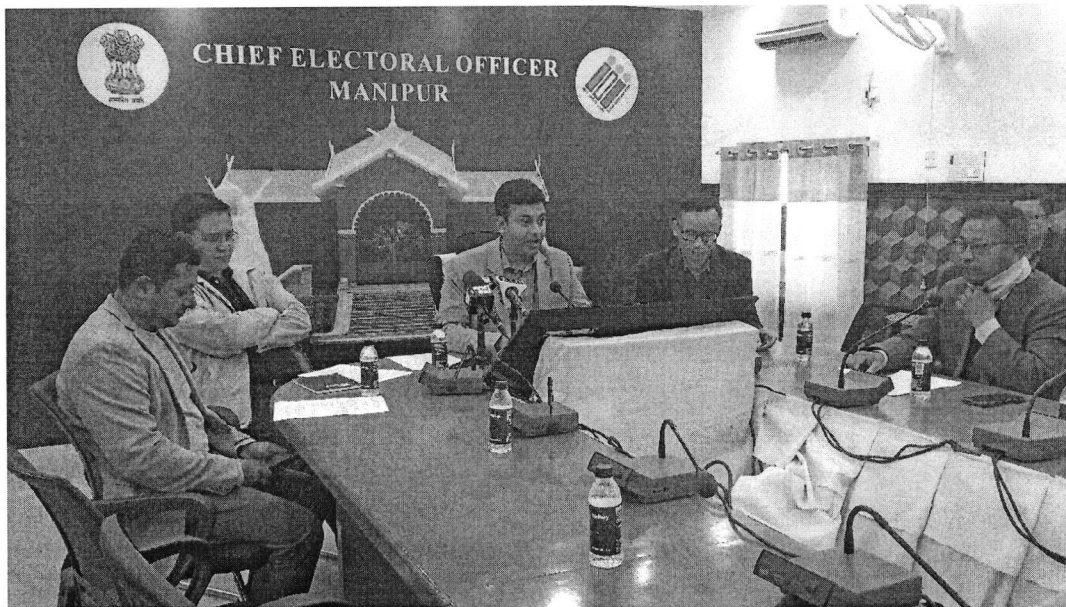


MINUTES OF MEETING WITH POLITICAL PARTIES ON SPECIAL SUMMARY REVISION-2024 HELD ON 22nd JANUARY, 2024 AT THE CONFERENCE HALL OF CHIEF ELECTORAL OFFICER, MANIPUR AT LAMPHELPAT, IMPHAL CHAIRED BY SHRI PRADEEP KUMAR JHA, CHIEF ELECTORAL OFFICER MANIPUR.

2. At the outset, the Chief Electoral Officer, Manipur welcomed all the representatives of the political parties present in the meeting and placed that the meeting was taken specially to discuss on matters relating to Special Summary Revision-2024. He also stated that the political parties are an important stakeholder and hence their suggestions and feedback are very crucial especially in view of the forthcoming Lok Sabha Election-2024.

3. Shri Pradeep Kumar Jha, Chief Electoral Officer, Manipur highlighted the following points.

I. Publication of Final Electoral Rolls, 2024:

- i. It was highlighted that as per the schedule fixed by the Election Commission of India, the Final Photo Electoral Rolls of all 60 (sixty) Assembly Constituencies have been published on the 22nd January, 2024 by the concerned Electoral Registration Officers (EROs).
- ii. It was also stated that as per the Final Electoral Rolls 2024, Gender Ratio stands at **1068** as compared to **1066** in Draft Electoral Rolls published on 27th October, 2023. The Elector Population (EP) Ratio is recorded at **55.54%** as compared to **55.04%** in the draft rolls. The total number of Electors as per Final Electoral Rolls is **20,26,623** showing a net increase of **18,191** electors from the Draft Electoral Rolls.
- iii. It was also informed that the total number of newly enrolled electors is **34,700 with 15,596 Male, 19,095 Female and 9 Third Gender**. As many as **16,509** electors including **5280 expired, 9205 shifted and 1977 repeated entries** have been deleted from the electoral rolls during the Revision period. The total number of service electors enrolled in the Final Electoral Rolls is **21,832** with 97 inclusions and 38 deletions during the revision period.

II. Status of Purification of Electoral Roll:

i. Status of Photo Similar Entries (PSEs):

It was placed that during the revision period, a total of **15635 PSEs** cases were reported in the ERONET and **100% verification** was completed. A total of **9987 cases** were found to be genuine and retained in Electoral Roll. A total of **4336 PSE cases** were found to be duplicate and hence deleted from electoral rolls.

ii. Status of Demographically Similar Entries (DSEs):

It was also informed that during the revision period, a total of **519 DSEs** cases were reported in the ERONET and **100% verification** was been completed. A total of **266 cases** were found to be genuine and retained in Electoral Roll. A total of **253 cases** were found to be duplicate and hence deleted from the electoral roll.

III. Miscellaneous

i. Familiarization & Demonstration of EVM & VVPAT

Chief Electoral Officer, Manipur highlighted that Familiarization & demonstration of EVM & VVPATs through Mobile Demonstration Vans (MDV) covering all Assembly Constituencies and EVM demonstration centers in all district headquarters have been taken up in connection with upcoming General Election to Lok Sabha 2024.

ii. 2nd First Level Checking (FLC) of EVM & VVPAT.

Chief Electoral Officer, Manipur informed that the 2nd First Level Checking (FLC) of EVMs & WPATs for the newly allocated machines is scheduled to start from 27th January 2024 onwards in connection with the upcoming General Election to Lok Sabha, 2024.
