This Committee will entertain applications for certification for advertisement on television channel and cable network by all registered political parties having their headquarters in that State and all organizations or groups of persons or associations having their registered offices in Manipur State.

3. Further, the Returning Officer of No.I-Inner Manipur and No.II-Outer Manipur (ST) Parliamentary Constituencies is also hereby declared as Designated Officer for the purpose of entertaining application for certification of an advertisement proposed to be issued on cable network or television channel by an individual candidate contesting the election from the PC of which such Designated Officer is the RO. The said RO may co-opt any of the Assistant Returning Officers, not below the rank of a SDM belonging to the State Provincial Civil Service to assist him in the task of certification of applications.

4. The applications for certification of any advertisement by every registered political parties and every contesting candidates shall be made to the aforesaid Committee or the Designated Officer mentioned above, as the case may be, not later than 3(three) days prior to the date of the commencement of the telecast of such advertisements. Where an application for certification of advertisement is by any other person or unregistered political parties, it will have to be made not later than 7(seven) days prior to the date of telecast.
