## **PRESS NOTE**

Imphal, the 29th October, 2024.

**No. e-Roll/2/2023-ELEC-ED-Part (1):** As per the schedule fixed by the Election Commission of India, the Draft Photo Electoral Rolls of all 60 (sixty) Assembly Constituencies have been published today, the **29**<sup>th</sup> **October, 2024 (Tuesday)** by the concerned Electoral Registration Officers (EROs).

- 2. The General Public/Electors and representatives of Political Parties may inspect/verify the Draft Photo Electoral Rolls at the offices of the Electoral Registration Officers/Assistant Electoral Registration Officers and with all the Booth Level Officers (BLOs) and they may also visit Chief Electoral Officer, Manipur's website <a href="https://ceomanipur.nic.in">https://ceomanipur.nic.in</a> to inspect the Draft Photo Electoral Rolls.
- 3. Further, 1 (one) printed copy of the Draft Electoral Rolls of each Assembly Constituency will be made available free of cost to the recognised National and State Political Parties. The recognised State/National parties may depute one representative of their party, duly authorised (in writing), to the CEO's office for this purpose. Any additional copy can be purchased @ Rs. 2/-per page and @ Rs. 1/- per half page or part thereof. Interested parties may also purchase DVD-ROMs from CEO's Office, Lamphelpat @ Rs. 100/- per DVD-ROM per Assembly Constituency
- 4. As per the Draft Electoral Rolls 2025, gender ratio stands at 1069 as compared to 1068 in Final Electoral Rolls, 2024 published on January 22, 2024 (Monday). The Elector Population Ratio is recorded at 54.84% as compared to 55.54% in the previous rolls. The total number of electors as per draft electoral rolls is 20,34,660 showing a net increase of 8037 electors from the Final Electoral Roll 2024 (20,26,623). The total number of polling stations remains at 2955.
- 5. The Special Summary Revision w.r.t to 01.01.2025 as the qualifying date starts from today with the publication of Draft Electoral Roll. Detailed schedule is given below:

During this period, one can enrol, delete from, make corrections and apply for shifting of his/her name in the electoral roll. Application forms may be submitted to the Electoral Registration Officers, Assistant Electoral Registration Officers and Booth Level Officers through physical forms. Application forms may also be submitted online at (1) <a href="https://voters.eci.gov.in">https://voters.eci.gov.in</a> and (2) Voter Helpline Mobile App.

- 6. Applicants, becoming eligible with the prescribed age of 18 years and above with 1st January, 2025 as qualifying date and subsequent qualifying dates of the year i.e. 1st April 2025, 1st July 2025, and 1st October 2025 can submit their claims in Form-6, in advance, beginning from the date of draft publication of electoral roll (29th October, 2024). The applications received related to qualifying date 1st January will be processed as per schedule and electoral roll be updated with final publication. While the forms/claims w.r.t the three subsequent qualifying dates of the year, received in advance, during the SSR period and continuous updation thereafter shall be processed by the EROs under continuous updation during the relevant quarter, preferably in the first month of the quarter.
- 7. In order to enrol more young voters in the electoral rolls, intensive activities will be taken up in Educational Institutions, Universities and Colleges during the Revision period. Electoral Literacy Clubs will also be activated in all Schools/Colleges. Special camps will be organized in Schools/Colleges/Universities/ to create awareness and facilitate registration of prospective voters in the electoral rolls. Special drives will also be undertaken to facilitate Internally Displaced People to enrol their names in the electoral rolls.
- 8. A SVEEP campaign for Special Summary Revision 2025 on the theme *Eikhoi Voter Challasi* was launched today by Shri Pradeep Kumar Jha, Chief Electoral Officer, Manipur. Mobile Vans with the message of electoral inclusiveness was flagged off from the Office of the Chief Electoral Officer, Lamphelpat, Imphal. The Mobile Vans will be reaching out to every nook and corner of the State. As part of the campaign a radio jingle and a street play on electoral inclusion were also released.
- 9. Chief Electoral Officer, Manipur hereby appeals all eligible citizens to come forward and enrol their names in the electoral rolls and seeks their active participation during the Special Summary Revision.
