NOTIFICATION

No. 100/MR-LA/3/2020:- WHEREAS, the seat of Shri Oinam Lukhoi Singh, in the Legislative Assembly of the State of Manipur elected from 22-Wangoi Assembly Constituency, has become vacant on 11.08.2020, by reason of his resignation;

- WHEREAS, a bye-election is to be held for the purpose of filling the vacancy so caused;
- 3. NOW, THEREFORE, in pursuance of Sub-Section(1) of Section 150 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby-
 - (A) calls upon the said 22-Wangoi Assembly Constituency in the State of Manipur to elect, before the 12th November, 2020 (Thursday) and in accordance with the provisions of the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the Legislative Assembly of the State;
 - (B) appoints, with respect to the said election,-
 - (a) the 20th October, 2020 (Tuesday), as the last date for making nominations;
 - (b) the 21st October, 2020 (Wednesday), as the date for the scrutiny of nominations;
 - (c) the 23rd October, 2020 (Friday), as the last date for the withdrawal of candidatures;
 - (d) the 7th November, 2020 (Saturday), as the date on which a poll shall, if necessary, be taken; and
 - (e) the 12th November, 2020 (Thursday), as the date before which the election shall be completed; and
 - (C) fixes the hours from 7.00 A.M. to 5.00 P.M, as the hours during which the poll shall, if necessary, be taken in the date specified above, for the election.
