

NOTICE OF ELECTION




Notice is hereby given that :-

- (2) nomination papers may be delivered by a candidate or by any of his proposers to the **Returning Officer** or to **Mangte Jonathan Kom, Assistant Returning Officer**, at the **Office of the Returning Officer/BDO, Wangjing Tentha, Mini Secretariat, DC Thoubal Office Complex, Thoubal** between **11 A.M. and 3 P.M.** on any day (other than public holiday) not later than the **20th October, 2020 (Tuesday)**;
- (3) forms of nomination paper may be obtained at the place and times aforesaid;

- (6) in the event of the election being contested, the poll will be taken on the **7th November, 2020 (Saturday)** between the hours of **7 A.M.** and **5 P.M.**
