

No.DEO/DC(TBL)/31/Nomination/LS19: In pursuance of Section 31 of the Representation of People Act, 1951 read with Rule 3 of the Conduct of Election Rules, 1961 and further in pursuance of Notification No. 464/EP/2019(1) dated 18th March, 2019 of the Election Commission of India issued by the Chief Electoral Officer, Manipur vide Extra Ordinary Gazette Notification No. 514 Monday, 18th March, 2019, notice is hereby given that:

- (1) an election is to be held of a member to the House of the People in No.2- Outer Manipur (ST) Parliamentary Constituency;
- (2) nomination papers may be delivered by a candidate or any of his proposers to Smt. Haobam Rosita, Returning Officer (RO) for No.2- Outer Manipur (ST) Parliamentary Constituency/DEO, Thoubal or to Shri. L. Radhakanta, Assistant Returning Officer (ARO)/ADM, Thoubal (specified Assistant Returning Officer) either at **the Office of the District Election Officer/DC, Thoubal District H.Q or Office of the Additional Deputy Commissioner, Thoubal District H.Q** between 11:00 a.m. and 03:00 p.m. on any day (other than public holidays) not later than **25th March, 2019 (Monday)**;
- (3) forms of nomination paper may be obtained at the place and time aforesaid;
- (4) nomination papers will be taken up for scrutiny at the Office of the District Election Officer/DC , Thoubal [Returning Officer for No.2-Outer Manipur (ST) Parliamentary Constituency] on **26th March, 2019 (Tuesday)** at 11:00 a.m.;
- (5) notice of withdrawal of candidature may be delivered either by a candidate or by any of his/her proposers or by his/her election agent who has been authorised **in writing** by the candidate to deliver it to either of the Officers specified in paragraph (2) above at the Office of the District Election Officer/DC, Thoubal [Returning Officer for No.2 - Outer Manipur (ST) Parliamentary Constituency]/Office of the Additional Deputy Commissioner, Thoubal before **03:00 pm on 28th March, 2019 (Thursday)**;
- (6) in the event of the election being contested, the poll will be taken on **11th April, 2019 (Thursday) between the hours of 07:00 a.m. and 04:00 p.m.**
