3. **TERMS & CONDITIONS:**

- i) All Tenders/Bids shall be accepted only through online and no manual submission of the same shall be entertained.
- ii) The number of mobile handset may increase/decrease subject to requirement/exigencies.
- iii) Specification is as per Annexure.
- iv) Rate quoted should be inclusive of all taxes.
- v) The rates quoted must be both in figure and words and it must be firmed for a minimum period of 6 (six) months subject to physical verification.
- vi) Arrangement for transportation of delivery of items/ materials to be made by the firm itself.
- vii) No advance should be provided and 100% payment will be made on delivery within 10(ten) days of receipt of the materials in full and good condition. All payment will be made by cheque or Net Banking.
- viii) Authorization from manufacturers shall be submitted.
- ix) All documents/papers uploaded/submitted by the bidder must be legible.
- x) The tender fees of **Rs.5,000/-** (non refundable) should be submitted in the form of Bank draft of any Nationalised Bank/ Scheduled Commercial Bank payable at Imphal drawn in favour of Chief Electoral Officer, Manipur.
- xi) An Earnest Money Deposit of Rs. **7,500/-** (refundable) is to be submitted in the form of bank draft of any Nationalised Bank/ Scheduled Commercial Bank payable at Imphal drawn in favour of Chief Electoral Officer, Manipur.

- xii) All Bank drafts should be submitted in a separate Envelope by indicating tender identification details (e.g. Tender Fee/EMD for supply of mobile phones etc.)
- xiii) PAN card copy should be submitted.
- xiv) **Balance sheet** for **last three years** should be submitted.
- xv) A summarised sheet of **turnover of last three years** certified by a registered Chartered Accountant should be submitted.
- xvi) **Experience certificate** for supply of related field should be submitted.
- xvii) The bidders shall have **GSTIN** Registration. Documentary proof to be submitted.
- xviii) The bidder shall be a registered Company. Documentary proof to be submitted.
- xix) The bidder shall have valid trade license to Sale/ Supply the items in question. Documentary proof to be submitted.
- xx) Bid will be opened in the chamber of Principal Secretary-cum-Chief Electoral Officer, Manipur at Lamphelpat.
- xxi) The Department shall not be responsible for any delay in postal service or disruption of web service.
- xxii) The Authority reserves the right to accept or reject any or all tenders without assigning any reason thereof. The office can also modify the terms and conditions before giving supply order.
- xxiii) The Authority reserves the right to cancel all bids without assigning any reason thereof.
