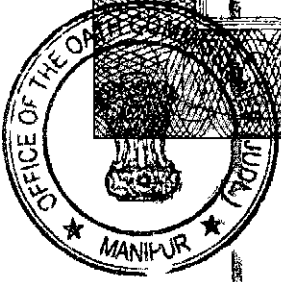

1. In Schedule

(i) copy of the order containing list of all vehicles for which permit issued by the Regional Transport Authority (RTA) for the vehicle used by the candidate his relative agent are used for election purposes, and (ii) if such vehicles, except one vehicle used and used by the candidate, not used for election purposes for such vehicle, shall be included in total amount of expenditure in the above table.

2. In all schedules if an expenditure on goods and services, provided by the Political Party, any person, company, firm, associations, body of persons etc on behalf of the candidate, the value of such goods or services are to be indicated, in respective columns.

3. In Part - III, the Lump-sum amount of fund received from the political party or other persons or funds, should be mentioned date wise. In all such cases such amounts are required to be deposited in the account of the candidate, opened for election expenses.

4. Each page of the Abstract Statement should be signed by the candidate.
