Your attention is invited to Section 77 of the Representation of the People Act, 1951 which stipulates that every candidate at an election shall, either by himself/herself or by his election agent. Keep a separate and correct account of all expenditure in connection with the election between the date on which he has been nominated and the date of declaration of the result thereof, both the dates inclusive.

- 2. Your invitation is also invited to Section 78 of the said Act which further stipulates that every contesting candidate at an election shall, within thirty days from the date of election of the returned candidate, lodge with the District Election Officer, an account of the election expenses which shall be a true copy of the account kept by him or his election agent under Section 77 of R.P. Act, 1951.
- 3. Even if a contesting candidate does not seriously contest the election, for any reason whatsoever, and incurs only a normal expenditure on his security deposit, etc. he is required by law to lodge his account of election expenses.
- 4. A contesting candidate who fails to comply with the requirements of law regarding the lodging of account of election expenses is liable to be disqualified by the Election Commission under section 10A of the Representation of the People Act, 1951 for a period of three year.
