No. 23/LET/ECI/FUNC/ERD-ER/2016-Vol. III : Whereas, the Election Commission had announced the schedule for Special Summary Revision of electoral rolls with reference to 01-01-2017 as the qualifying date in all States/UTs including Manipur vide its letter No. 23/2016-ERS (Vol. III), dated 12th August, 2016; and

Whereas, the period of filing claims and objections in Manipur was originally fixed from 7th September, 2016 to 7th October, 2016; and

Whereas, the draft rolls were published on 7th September, 2016 in the State; and

Whereas, Chief Electoral Officer, Manipur has requested for extension of the period of filing claims and objections due to certain administrative reasons and also in view of the forthcoming general election to State Legislative Assembly; and

Whereas, the Election Commission has considered the matter and decided that the period of filing claims and objections in Manipur should be extended up to 21st October, 2016 (Friday);

Now, therefore, the Election Commission, in exercise of the powers conferred by proviso to Rule 12 of the Registration of Electors Rules, 1960, extends, for all Assembly Constituencies in the State of Manipur, the period for filing claims and objections upto 21st October 2016 (Friday) for ongoing Special Summary Revision of electoral rolls with reference to 01-01-2017, as the qualifying date.
