

Proceedings of the meeting of Recognized National/State political parties, ADM/Imphal West District, SDOs/EROs/ROs, AEROs of Imphal West District held on 6<sup>th</sup> October, 2016 at 12.15 pm at the Kombirei Hall of Deputy Commissioner office complex at Lamphelpat in connection with the Special Summary Revision of Photo Electoral Roll, 2017, Systematic Voters' Education and Electoral Participation (SVEEP) and forthcoming 11<sup>th</sup> State Assembly Election, 2017, with Shri Robert Singh Kshetrimayum, District Election Officer/DC, Imphal West District in the chair.

At the outset District Election Officer/DC, Imphal West District welcomed all the members present. He informed that the Election Commission of India and Chief Electoral Officer, Manipur has directed to carry out Special Summary Revision of Photo Electoral Roll, 2017, vide letter No. 23/2016-ERS(Vol. III) dated 12<sup>th</sup> August, 2016 and No. 2/ELEC/SSR/2017 dated 17<sup>th</sup> August, 2016 respectively. He informed in the meeting that the SDOs/EROs of Lamphel, Lamsang, Patsoi and Wangoi have since informed to carry out the action as per the revise scheduled fixed by the Election Commission of India and CEO, Manipur vide letter No. 23/LET/CI/FUNC/ERD-ER/2016 – Vol-III dated 19-09-2016 and No. 2/Elec/SSR/2017 dated 22-09-2016 respectively.

3. **Involvement of Booth Level Agents (BLAs) of Political Parties:** DC/DEO informed all recognized political parties to appoint a Booth Level Agent for each polling stations in respect of 9-Thangmeiband, 10-Uripok, 11-Sagolband, 12-Keishamthong, 13-Singjamei, 16-Sekmai(SC), 17-Lamsang, 18-Konthoujam, 19-Patsoi, 20- Langthabal, 21- Naoriya Pakhanglakpa, 22-Wangoi and 23-Mayang Imphal and to submit the claims and objection through BLOs at the designated location/polling stations within the prescribed scheduled period and also informed all that BLAs shall not submit more than 10(ten) forms to BLOs in a day as per ECI direction. DC/DEO also informed all concerned to detect errors in the current Photo Electoral Rolls, 2017 for necessary correction by the concerned SDOs/EROs.

4. In the meeting, all SDOs/EROs of Lamphel, Lamsang, Patsoi and Wangoi appeal to all representatives of political parties present to appoint Booth Level Agents (BLAs) and to give co-operation to all concern Booth Level Officers (BLOs) for smooth conduct of Special Summary Revision of Photo Electoral Rolls, 2017. SDOs/EROs also informed the political parties representatives not to submit the related forms in bulk.

5. Further, in the meeting, representatives of CPI(M) Shri. Kshetrimayum Santa proposed for giving lump-sum amount as remuneration to the Booth Level Agents (BLAs) as is given to Booth Level Officers (BLOs) for encouraging them in their duties.

6. Lastly, in the meeting, Congress representative, Shri Ch. Nimai Singh proposed for intimation/availability of the list of Booth Level Officers (BLOs) so appointed to all the political parties/general public for information and taking necessary action as and when required.

Concluding the meeting the Deputy Commissioner/DEO, Imphal West District requested all the members present to extend their fullest co-operation to the Election Functionaries of Imphal West District so that a correct and defect free electoral rolls may be prepared by the concerned SDOs/EROs of Imphal West District and for smooth conduct of the forthcoming 11th State Assembly Election, 2017.

Thereafter, the meeting ended with thanks from the Chair.
